OPSEU's Broader Public Service Conference is a gathering of members from across the province who belong to bargaining units in OPSEU's largest sector. You are front-line and support staff in community agencies, universities, casino workers, hospital and community health professionals and support workers, youth workers, education workers, social services professionals and support staff, and Paramedics, to name a few. You are almost 70,000 members strong and part of more than 100,000 working families belonging to OPSEU.

How do I get there?

Locals or Bargaining Units must hold elections as per OPSEU Policy to determine who your delegate(s) will be.

- If you are bringing your spouse, you are required to pay half of the cost of the room.
- If single accommodation is requested, you will be expected to absorb the difference between shared accommodation and single cost as per OPSEU policy.
- OPSEU will pay accommodation only for delegates travelling in from more than 60 km.

3. **Booking Childcare**

According to OPSEU policy:

- Members who bring their child(ren) to union events will be entitled to single accommodation
 and meal expenses. Their child(ren) must be registered and attending to qualify. All children (16
 years or younger), accompanying delegates must be registered and in attendance.
 If they are not registered, and not attending, single accommodation and meals will not be
 honoured.
- The meal allowance for children 12 years of age and under is 50 per cent of OPSEU's standard meal allowance.
- If a spouse accompanies the member and the child(ren) to an OPSEU function, the member should bear the cost of the private room and no expenses (travel or meals) will be paid for the child(ren) or the spouse.
- Child and dependent care claims must be signed by the care provider and may be verified by Head Office before reimbursement is made when claiming care at home.
